3. Nemoforum activities

Nemoforum events:

- "Register of Flats" (23.4.2008, Prague, 40 participants) a working seminar organized for invited group of participants concluded with a preliminary idea of register of flats as an agenda register related to the RUIAN (register of territorial identification and real estates), with necessity to identify a body (bodies) responsible for initialization of relevant legislative steps.
- "Unified Digital Technical Map" (27.11.2008, Prague, 40 participants). An internal seminar of Nemoforum, initiated by representatives of Utilities. Discussion on so called "purpose cadastral map" being created in several regions in co-operation of municipalities and cadastral offices. Within the seminar, an important document "Memorandum on co-operation on the Project of Digital Map of Public Administration" was signed by representatives of Ministry of Interior, Ministry of Environment and the COSMC (later also Ministry of Regional Development, Union of Municipalities and Association of Regions).
- "Digitization of Cadastral Maps" (4.12.2008, Prague, 100 participants) the seminar with
 presentation of results of pilot projects on public-private co-operation (COSMC private
 companies) in digitization of cadastral maps in selected regions. Also some more detailed
 information concerning the conditions for contracting-out some works in this field has been
 given by the COSMC legislative dept.

Other events with participation of Nemoforum:

- "INSPIRE and Network services in the Czech GIS" (4.2.2008, Prague) a seminar organized by CENIA, oriented on proposal of Implementation rules for Network services.
- "Geoinformatics for everybody" (28. 31.5.2008, Brno) a conference organized by CAGI. Within the conference, a seminar on INSPIRE development was held with the discussion on issues of INSPIRE impact on SDI in the CR.
- "INSPIRE 123 we don't wait" (17.10.2008, Prague) a seminar organized by CAGI. News and challenges of INSPIRE implementation.
- "INSPIRE Let's inspire by the data" (19.11.2008, Prague) a conference organized by CENIA.
